

Introduction

This policy statement sets out the School's arrangements for managing the access of providers to students at the School for the purpose of giving them information about the providers' education or training offer. This complies with the School's legal obligations under Section 42B of the Education Act 1997.

Student Entitlement

All students in Years 8 -13 are entitled to:

- find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point
- hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through options events, assemblies and group discussions and taster events
- understand how to make applications for the full range of academic and technical courses

For students of compulsory school age these encounters are mandatory and there will be a minimum of two encounters for students during the 'first key phase' (Years 8 and 9) and two encounters for students in the 'second key phase' (Years 10 and 11). For students in the 'third key phase' (Years 12 and 13), particularly those that have not decided on their next steps, there are two more provider encounters available during this period, which are optional for students to attend.

Premises and facilities

The School will make the main hall, classrooms or private meeting rooms available for discussions between the provider and students, as appropriate to the activity. The School will also make available AV and other specialist equipment to support provider presentations. This will all be discussed and agreed in advance of the visit with the Careers Leader or a member of their team.

Providers are welcome to supply a copy of their prospectus or other relevant course literature to be placed in the Careers Library, placed in the School Library. The Library is available to all students at lunch and break times.

These provider encounters will be scheduled during the main school hours and the provider will be given a reasonable amount of time to, as a minimum:

- Share information about both the provider and the approved technical education qualification and apprenticeships that the provider offers
- Explain what career routes those options could lead to
- Provide insights into what it might be like to learn or train with that provider (including the opportunity to meet staff and students from the provider)
- Answer questions from students

Meaningful provider encounters

One encounter is defined as one meeting/session between students and one provider. Meaningful online engagement is also an option, and we are open to providers that are able to provide line online engagement with our students.
